AMENDMENT OF GENERAL PLAN OF DEVELOPMENT - MEADOWPARK

WHEREAS, on the 12th day of April, 1979, by instrument recorded in Volume 666, Page 55 of the Deed Records of Midland County, Texas, Citizens Savings & Loan Association did cause certain covenants and restrictions to be executed and imposed upon Meadowpark, First Section, an Addition to the City of Midland, Midland County, Texas; and

WHEREAS, the original declaration of covenants and restrictions had attached thereto as Exhibit B a general plan of development; and

WHEREAS, Article II, Section 3(b) of such declaration provided for amendment to the general plan of development for land not subject to the original declaration; and

WHEREAS, Citizens Savings & Loan Association now desires to amend such general plan of development to provide for relocation of Common Area F containing the recreational facilities to a more centralized location in Meadowpark Addition;

NOW, THEREFORE, pursuant to the provisions of Article II, Section 3 of said original declaration of covenants and restrictions pertaining to Meadowpark Addition, Section 1, hereinabove described, Citizens Savings & Loan Association as developer does hereby amend the general plan of development as illustrated in Exhibit B attached to said original declaration of covenants and restrictions and declares that hereafter, unless further amended pursuant to said Article II, Section 3, the general plan of development for Meadowpark Addition shall be as depicted in the amended site plan dated December 5, 1980, and attached hereto as Exhibit A, and that pursuant to Article II, Section 2(a) of said original declaration of covenants and restrictions, Common Area F as shown in said amended general plan of development is hereby subjected to said original declaration of covenants and restrictions to the same extent that all other common area is covered thereby. Also, attached hereto as Exhibit B is the final plat of Common Area F as approved by the City of Midland.

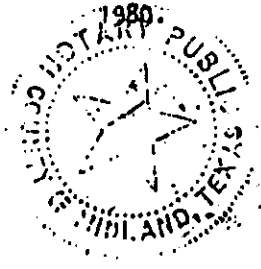

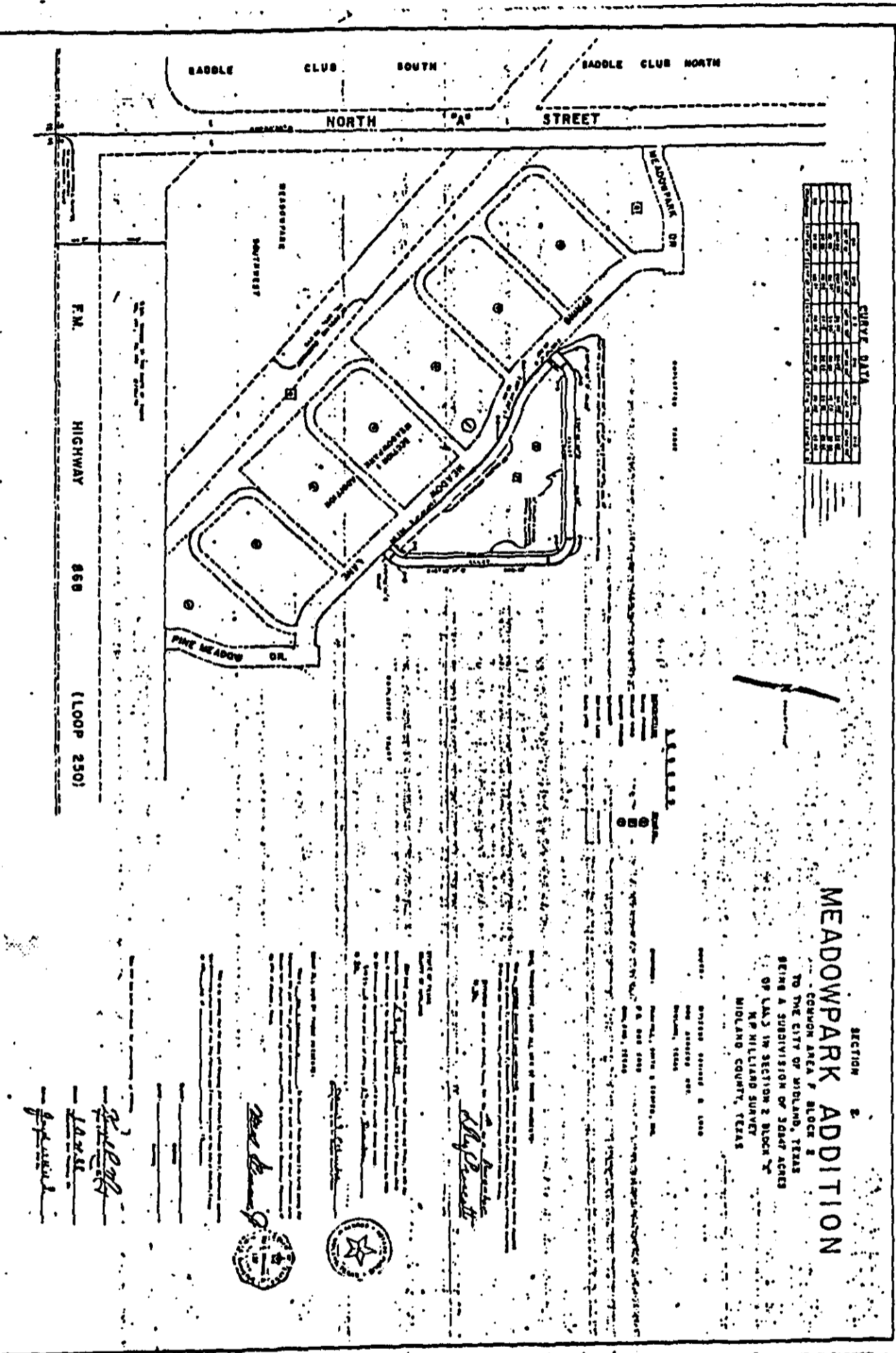
